2011 Spring Turkey Contest

For all hourly ATI/Speedway Unit, RR/Maywood Unit, Ryder Integrated Logistics Unit and PMI Unit employees, retirees and their immediate family.

RULES: All hunting laws of Indiana will be complied with. Winner will be decided by combination of weight, \*beard and spur length. Any ties will share equally in prize.

\*The longest beard will be counted, i.e. double beard (longest beard).

\$100 Youth Season Prize

18 years-old or younger, still in high school (child, stepchild, grandchild or step-grandchild of member) Youth winner is eligible for Regular Season Prize.

\$300 Regular Season Prize

Every paid entrant that checks in a bird (harvested and checked-in bird) will go into a pool for drawing at end of contest season. Example: If you win \$300 Regular Season Prize, you are still eligible for and entered in drawing at season's end. If you do not win Regular Season Prize but checked-in and harvested bird you are still eligible for and entered in drawing at season's end. The more paid entries/checked-in birds, the larger the amount awarded.
